- **Traders to be given status of MSME** (In a recent statement Hon' ble Sh Nitin Gadkari ji has indicated for same)
- **Preventing Government to stop cheque facilities for Businesses.**
- **Rationalisation of various provisions and rates in GST**



Major Issues Taken Up



- **Persuaded Government to waive MDR on acceptance of payment by Digital mode**
- **Major role played in formulation policies for e-commerce, FDI based wholesale cash N Carry and corporate based chain of retail sectors.**
- **Only organisation which has submitted draft National Retail Policy to Ministry of Commerce.**



Major contribution on Issues with Government



- **Regular attendee in meetings with various Ministries of Central Government and strongly put traders views on various policies.**
- **During Lockdown, was actively in touch with Ministry of Home Affairs for getting various grievances resolved.**



Major Issues Taken Up



- **Represented to FSSAI to waive license renewal condition for the year 2020-21 as most of food businesses were not in operation due to Covid pandemic situation.**
- **Represented to FSSAI to review its order for putting date of manufacturing and best before date in case of loose sweets.**



Major Issues Taken Up



- **Requested all state governments to waive off Road tax and insurance premium for the period when commercial vehicles were not on roads due to Lockdown. UP and West Bengal have already announced some relief. Other states are likely to follow suit.**
